Order:

The Hon'ble Minister for Tourism, while moving the Demand for Tourism Department on 30.08.2011, has made the following Announcement in the Tamil Nadu Legislative Assembly:-

“As per the orders of the Hon'ble Chief Minister, Rest Houses, Cloak Room and Toilet facilities will be provided at famous pilgrim centers -Thirukkadayur, Thirukkostiyur, Rameshwaram, Palani, Srivanchiyam, Aykudi and Navagraha Shrine Temples for the benefit of the pilgrims”.

2. The Commissioner of Tourism, in his letter read above has sent necessary proposals to provide Tourism Infrastructural facilities at Srivanchiyam (Siva Temple) near Nannilam in Thiruvarur District. In his letter, the Commissioner of Tourism has stated that, a proposal has been received from the Commissioner of Hindu Religious and Charitable Endowments, Chennai for providing tourist facilities at Srivanchiyam, Thiruvarur District at a total cost of Rs.43,60,000/- and he has also stated that at present no infrastructural facilities are available at the temple. The details of facilities to be provided are as follows:-

3. The Commissioner of Tourism has requested that a sum of Rs.43,60,000/- (Rupees forty three lakhs and sixty thousand only) may be sanctioned (100% Tourism Department share) for the implementation of the above scheme. He has further requested that the Commissioner of Tourism, Chennai may be authorized to draw the

amount to be sanctioned and disburse it to the Commissioner, Hindu Religious and Charitable Endowments Department, Chennai to execute the works.

4. The Government after careful examination, accord administrative and financial sanction to take up works as detailed above at an estimated cost of Rs.43.60 lakhs (Rupees Forty Three Lakh and Sixty Thousand only) at Srivanchiyam (Siva Temple), near Nannilam in Thiruvavarur District.

5. The expenditure sanctioned in para 4 above shall be debited in the following head of account:

“5452-Capital Outlay on Tourism – 01- Tourist Infrastructure -
101 – Tourist Centres – Schemes in the Eleventh Five Year
Plan-II State Plan – KV - Improvement of Basic Facilities in
Tourist Centres – 16 Major Works.”

6. The Director of Tourism shall draw the amount sanctioned above and disburse to the Commissioner, Hindu Religious and Charitable Endowments Department, Chennai.
